F -- PCB REMEDIATION AT MAMMOTH 2 SUBSTATION (COMBINE)

NAICS: 562910. THIS IS AN INDIAN SMALL BUSINESS ECONOMIC ENTERPRISE (ISBEE) SET-ASIDE. The Bureau of Indian Affairs-Western Regional Office requires a contractor to remediate PCB impacts to soil and concrete underlying an active transformer pad at the Mammoth 2 Substation, which is owned and maintained by the Bureau of Indian Affairs' San Carlos Irrigation Project (SCIP). The Substation is located in Pinal County, Arizona. Work includes preparation of a project workplan, removal of the concrete slab after temporary removal of the transformer and removal of the soil underneath the concrete pad to a depth of 24 inches below ground surface, verification by a certified State of Arizona that laboratory that soils were cleaned up to the EPA RSL industrial cleanup level of 1 ppm, site preparation activities, and disposal of PCB-contaminated soil in accordance with the requirements in 40 C.F.R. § 761.61(a)(5). At the conclusion of the remedial excavation, a closure report documenting the removal and disposal of the PCB-contaminated concrete and soil shall be prepared.
