The U.S. Department of Justice, Federal Bureau of Prisons, requires abatement of asbestos-containing materials (ACM) in the Federal Medical Center in Lexington, Kentucky. Work includes the remediation of ACM from ~16 12-foot wall cavities containing pipes insulated with ACM and the removal and disposal of all contaminated materials using an on-site dumpster provided by the contractor. The Federal Bureau of Prisons will provide Engineering Control-Critical barriers. The award will be a firm-fixed-price contract with a period of performance from May 5, 2025, to June 7, 2025. NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of Homeland Security requires a contractor to provide preventative and corrective maintenance services for two indoor FPS Firing ranges in Alexandria, Virginia. These services will be used to provide weekly maintenance services that will be used to test, inspect, repair, and perform preventive maintenance on the Caswell range target equipment, to restore equipment to fully operational condition to replace or repair parts of equipment subject to normal wear and tear and to provide bullet trap maintenance at the FPS Firing Ranges. The weekly range cleaning services will be used to reduce, to the greatest extent possible, the lead contaminates from surfaces within the ranges, the weapons cleaning rooms, and the control room/booth. The contractor shall design a checklist of the work to be performed and the contractors' employees shall complete the checklist of the work completed and provide the checklist to an FPS representative on a weekly basis. F -- INDOOR FIREARMS RANGE MAINTENANCE AND LEAD CLEANING SERVICES AD (COMBINE)

NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The Federal Bureau of Investigation requires a contractor to provide maintenance and cleaning services for two FBI indoor firearms ranges on Redstone Arsenal in Huntsville, Alabama. The purpose of this requirement is to establish and maintain a clean and healthy work environment that is free of airborne and surface heavy metals and to ensure all range ventilation air filtration systems function properly. Work includes vacuuming all floors, walls, and work surfaces with a contractor-furnished heavy-duty vacuum cleaner to remove lead residue; cleaning concrete floors, tile floors, target runners and rails, and horizontal working surfaces to remove heavy metal dust contamination (lead etc.) via an approved cleaning method; replacing air filters on prescribed schedules based on type; cleaning the rubberized trap system to remove lead contamination and wood/ paper debris encountered and cleaning the trap plates and Vortec collection system monthly; vacuuming and wet cleaning all shooting stalls/ benches with nontoxic, FBI-approved cleaning materials; and containerizing and preparing for disposal, all hazardous waste generated as the result of services rendered under this contract. A. The granulated rubber berms may require mining for lead as requested by the FBI through exercising the option. Berm mining, as requested, is only included as an option to be exercised and is not a part of the base of the contract. The Contractor must provide a crew leader /project manager/ lead technician with valid RCRA/ HAZCOM and Lead hazard awareness training certifications on-site for the entire duration that any member of the contractor staff is present during contract performance. Quoters are encouraged to attend the site visit, which is scheduled on May 5, 2025. The site visit is limited to two participants from each firm, and each firm must submit its request to attend the site visit by 11:00 AM CST on April 30, 2025. The award will be a firm-fixed-price contract with a one-year base period and four one-year option periods. OFFERS ARE DUE BY 11:00 AM CST ON MAY 16, 2025.

F -- NORTHWESTERN DIVISION REGIONAL \$245 MILLION PRE-PLACED REMEDIAL ACTION CONTRACT INDEFINITE DELIVERY / INDEFINITE QUANTITY MULTIPLE AWARD TASK ORDER CONTRACT (PRESOL)

NAICS: 562910. WHEN THIS SOLICITATION IS RELEASED ON OR ABOUT EARLY TO MID JUNE 2025, IT WILL BE COMPETED AS AN 8(A) SET-ASIDE. The United States Army Corps of Engineers Northwest Division (NWD) requires a contractor to provide services under its Pre-Placed Remedial Action Contract (PRAC), Multiple Award Task Order Contract (MATOC). Work will support hazardous, toxic, and radioactive waste (HTRW) remediation projects for both civilian and military agencies of the Federal Government. The majority of the task orders will provide remedial action services and related incidental construction to meet the

requirements of laws and programs such as the Resource Conservation and Recovery Act (RCRA); the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA); the EPA Brownfields Program; the National Oil and Hazardous Substances Pollution Contingency Plan (NCP); the Clean Water Act; the Clean Air Act; and other related Federal Programs, in addition to state/local specific regulations/requirements dealing with hazardous waste management/disposal, Underground Storage Tanks (USTs), and other fuels-related issues. Remedial actions may address both regulated and non-regulated toxic substances. The task orders will also support the Defense Environmental Restoration Program (DERP); environmental compliance and pollution prevention projects under the Department of Defense Environmental Quality Program; the Formerly Utilized Sites Remedial Action Program (FUSRAP); environmental cleanup activities under the Base Realignment and Closure (BRAC) Program; the Department of Homeland Security and the Federal Emergency Management Agency (FEMA); and other environmental and homeland security laws and regulations requiring support for military installations, Corps' civil works projects, and work for other federal agencies. The DERP projects will include Installation Restoration Program (IRP) activities on active Army and Air Force installations and on Formerly Used Defense Sites (FUDS). NWD encompasses five USACE Districts: Seattle (NWS), Walla Walla (NWW), Portland (NWP), Kansas City (NWK), and Omaha (NWS). In addition, this MATOC includes missions for NWK occurring within EPA Region 2 in the states of New York and New Jersey. The award will be a Northwestern Division (NWD) Regional \$245 million Pre-placed Remedial Action Contract (PRAC) Indefinite Delivery / Indefinite Quantity (IDIQ) Multiple Award Task Order (MATOC) with firm-fixed-price and cost-reimbursable task orders, or a combination of both.
